Personal security, employment, resources, health, property.



Short-termism is exacerbated by ideologies and relationships rooted in the past. An economically and mentally exhausted populace struggles to prevent unravelling of the social fabric, supported by some dedicated business and civic leaders. Impractical and ideological national policies continue to degrade the foundations of economic growth and social renewal.



Scenario 3: Some young leaders taking charge



Despite the clear consequences of the current trajectory, decisive leaders don't fully succeed in implementing change. Younger voices grow louder, take charge, and become catalysts for change, even in the absence of buy-in from accepted structures. 

- CrowdStrike: infrastructure, health, finance


• The Ugly:

- Largest exposures:
 - Food security risk (e.g., potato and tomato frost)
 - Logistics risk (e.g., N3 snow)
 - Fire risk
 - \circ Flood risk
 - $\circ~$ Ability to produce/secure food in the long run





- Interface between nature, food, people
 - Production, processing, logistics, consumption, waste management
 - $\circ~$ Speed and scale underestimated
- **Opportunities:**
